

THEIR ORIGINS

The country of Khazaria was located between Turkey and Russia in the northern Caucasus region. The Khazars became independent of the Turkic empire at the beginning of the 7th Century. They settled and dominated an area between the Caspian Sea and the Black Sea.



THEIR ORIGINS

Their independence lasted for about two centuries. A campaign was launched against them from Kiev in 965, and by 969, Khazaria was fully conquered and absorbed by Russia. They completely disappeared by the middle of the 13th century.

Around 740, King Bulan of the Khazars had the desire to embrace religion and inquired from 3 men.



King Bulan chose Judaism, converted, and brought others within His realm of influence to do likewise.


HASDAI IBN SHAPRUT'S ACCOUNT

• In the 10th Century, Spanish Jewish scholar Hasdai Ibn Shaprut was made aware of the story of the Khazars and decided to send emissaries to that region to investigate the possible Jewish connection.



KING JOSEPH'S LETTERS

• While they never got to meet with any Khazars, they received letters from someone known as King Joseph of the Khazars. The letters, though very detailed about the conversion, are widely believed to be forgeries.

- The Kuzari: A Book of Argument in Defense of a Despised Religion
- The book is written in the 12th century as a novel and giving preference to Judaism over the other faiths.



THE KHAZAR THEORY DEBUNKED BY ARCHEOLOGY

- in 1896, the discovery of The Cairo Genizah, was one of the greatest Jewish discovery.
- The storage facility contains some 400,000 medieval Jewish manuscript fragments currently spread out across several locations. Most of them being kept at the University of Cambridge.
- One fragment is known as the "Schechter Letter" or "Genizah Letter."



THE KHAZAR THEORY DEBUNKED BY ARCHEOLOGY

• The "Schechter Letter" is only a fragment of the original document, but it differs from the accounts found in the Kuzaria or The Hasdai ibn Shaprut Letters, in that it claims that Jews from Persia and Armenia fled persecution and found refuge in Kazariah.



 They would have been Judean Jews who moved to Kazariah and not Khazars who converted to Judaism.

THE KHAZAR THEORY DEBUNKED BY GENETICS

"We compared two genetic models for European Jewish ancestry depicting a mixed Khazarian-European-Middle Eastern and sole Middle Eastern origins.... We conclude that the genome of European Jews is a tapestry of ancient populations including Judaized Khazars, Greco-Roman Jews, Mesopotamian Jews, and Judeans and that their population structure was formed in the Caucasus and the banks of the Volga with roots stretching to Canaan and the banks of the Jordan."

THEIR ORIGINS


- Mayer Amschel Rothschild was the founder of the Rothschild banking dynasty. He was the son of Jewish merchants from the Frankfurt ghetto, born in 1744.
- Orphan at 12 with 4 siblings to care for.
- Became the apprentice to banker Jacob Wolf Oppenheimer in Hanover.
- He became the personal dealer to Crown Prince Wilhelm I in 1763 and began to amass his fortune as the French Revolution started in 1789.

THEIR ORIGINS

- He delegated his banking business to his 5 sons across Europe.
- They became major lenders to various countries during the Napoleonic Wars.
- The sons were very spread out across Europe and involved in helping various countries at war, and as a result, they sometimes found themselves on both sides of the same conflict.

THEIR REPUTATION

- The Rothschild name became synonymous with wealth and philanthropy, but it also became the symbol of modern Jewish capitalism.
- Sholem Aleichem's original Yiddish text for Tevye's song "If I were a Rich Man" read "Ven Ikh bin Rothschild" ("If I were Rothschild").

• In 1830, the antisemitic cartoon "11th Commandment" depicted a Jewish man saying: "get all you can get, keep what you get, give away nothing."






THE CARICATURES

• In 1898, the cartoon "Rothschild" symbolizing the whole banking dynasty, depicted a Jewish demon holding and controlling the world.




THE CARICATURES


THE CARICATURES

- This was a result of the belief that the Rothschilds were involved in the Dreyfus Affair, even though they had little or no connection to it.




THE CARICATURES

- Moneylenders had to pay a tax that kept increasing, forcing them to raise their interest rates several times.



"Rothschild power, as it was once known, has been so broadened by the entry of other banking families into governmental finance, that it must now be known not by the name of one family of Jews, but by the name of the race. Thus, it is spoken of as International Jewish Finance, and its principal figures are described as International Jewish Financiers. As a leading student of financial affairs puts it, the world of high finance is largely a Jewish world because of the Jewish financier's "absence from national or patriotic illusions."

POSSIBLE REASONS FOR THE ROTHSCHILD'S GREED THEORY

- The Battle of Waterloo (1815)
- Nathan Rothschild rushed to the coast of Belgium through the English Channel at a very high price, arrived in London a day before the news of Napoleon's defeat. The story goes on, claiming that the Rothschilds profit from Waterloo was 135 million pounds.
- The story was a hoax, as Nathan Rothschild was nowhere in the Waterloo region at that time.

POSSIBLE REASONS FOR THE ROTHSCHILD'S GREED THEORY

Wilhelm Marr, the very man who coined the word antisemitismus in 1879, had worked with a family close to the Rothschilds and had been turned down in 1841 for a promotion that was given to a "less deserving Jew." In one of his memoirs, he recalled that, "the goi had to bear the consequences of the economic crisis."




Edmond de Rothschild (1845-1934) was a strong supporter of Zionism. "The Known Benefactor"

and the Palestine Jewish Colonization Association (PICA founded in 1923) <u>purchased</u> a total of more than 125,000 acres in Palestine. These massive land purchases gave credence to the antisemitic claims that Jews control the banks and want to control the world.
















THEIR ORIGINS

- They were created from the plagiarism of Maurice Joly (1833-1878) titled, "Dialogue in Hell between Machiavelli and Montesquieu", a satire against Napoleon III.
- The very first documented publication of the *Protocols* was in 1903 in the St. Petersburg newspaper "Znamia" (The Banner) where it was titled "*Program for the Conquest of the World by the Jews.*"

THEIR ORIGINS

- •The current version of the *Protocols* were first published in 1905 as the final chapter of a book written on the Antichrist, by Russian mystic Sergei Nilus
- He claimed that they were the minutes from the First Zionist Congress that took place in Switzerland in 1897.
- They were translated in German in 1919, and after that, many other languages followed.

THE BIG LIE

 Jewish leaders are accused of plotting to take-over government, banks, business, education, religion and more.

THE BIG DECEPTION

- The Seven Mountains of Influence of the New Apostolic Reformation (NAR): family, religion, education, media, arts & entertainment, business, and government.
- Also known as Dominionism or Kingdom Now Theology.

THEIR SPREADING

 In the early 1920s, and for about a year and a half, the Protocols were also published by Henry Ford in his antisemitic newspaper The Dearborn Independent under the title The International Jew. Ford was sued for libel and had to issue an apology and pull all copies out of distribution.

THE Jew is again being singled out for critical attention throughout the world. In England he is charged with boing the real world ruler, who rules as a super-oation over the nations, rules by the power of gold, and who plays nation against nation for his own purposes, remaining himself discreetly in the background. A MODERN censes would show a large professional and literary class added to the traders, but no diminution of the percentage of traders and not much if any increase in the number of wage toilers. In America alone most of the big business, the trusts and the banks the natural resources and the chief agricultural products, especially tobacco, conton and sugar, are in the control of Jawish financiers or their agents. Jewish journalists are a large and powerful group here. "Large numbers of department stores are held by Jewish firms," says the Jewish Encyclopedia, and many if not most of them are run under Gentile names. Jews are the largest and most numerous landlords of residence property in the country. They are supreme to the theatrica world. Fewer than any race whose presence amone us is noticeable, they receive daily an arount of favorable publicity which would be impossible did they not have the facilities for creating and distributing it themselves. Werner Sombart, in his "Jew and Modern Capitalism" says, "If the conditions is America continue to develop along the same lines as in the last generation, if the immigration statistics and the proportion of births among all the nationalities remain the same, our imagination may picture the United States of fifty or a hundred years hence as a land inhabited only by Slavs. Negroes and Jews, wherein the Jews will naturally occupy the position of



• They were first published in Arabic in 1925. King Faisal of Saudi Arabia had them re-published for the Muslim world in the 1970s.

• Egyptian President Gamal Abdel Nasser produced a booklet based on the Protocols.





THEIR WEAKNESS: EXPOSED AS A FORGERY

• They have been exposed as a forgery since the late 1920s.

• 1936: Hugo Valentin, in his book "Antisemitism," characterized the Protocols as "the greatest forgery of the century."

THEIR WEAKNESS: EXPOSED AS A FORGERY

• 1938: Father Pierre Charles, Professor of Theology the Jesuit College in Louvain, France, stated, "It has been proved that these 'Protocols' are a fraud, a clumsy plagiarism. . . . made for the purpose of rendering the Jews odious."



THEIR WEAKNESS: EXPOSED AS A FORGERY

• 1964: the Senate Judiciary Committee issued a report repudiating the Protocols, "Every age and country has had its share of fabricated 'historic' documents which have been foisted on an unsuspecting public for some malign purpose. . . One of the most notorious and most durable of these is the 'Protocols of the Elders of Zion.'"

THEIR WEAKNESS: MIXED MULTIPLE SOURCES

According to Binjamin Segel in *A Lie and a Libel*, "To bring into harmony all the various, contradictory assertions, there is only one thing left for us to do. We must accept all of them as true: Just as Homer was said to have been born in seven Greek cities simultaneously, so Nilus translated the Protocols from the French and the Hebrew simultaneously.

THEIR WEAKNESS: MIXED MULTIPLE SOURCES

They were stolen by a noble woman of Tchernigov from a high Masonic dignitary and, at the same time, by the dignitary's wife or lover. This lady gave it to Nilus's friend, Sukhotin, who simultaneously appropriated it from an extensive book of protocols or lecture notes that he found hidden in an iron. They originated at the Basel Zionist Congress of 1897 and, at the same time, in the lecture notes of Paris students.

THEIR WEAKNESS: MIXED MULTIPLE SOURCES

In a chest at Zionist headquarters in France, but also in Alsace and in Switzerland. They were also stolen from Hertzl's house in Vienna and the secret vault of the Mizraim lodge. They were delivered to Nilus in 1897 by a Russian spy in equally by Sukhotin in 1901. At the same time the French translation of a Hebrew original was sent from Paris by Rashkovsky to the Russian interior ministry in 1897 and then delivered to Nilus.

THEIR WEAKNESS: CARELESS FORGERS MIXED DATES

The Protocols (supposedly written in 1897 at the First Zionist Congress) claim, "in order that our scheme [the total ruin of non-Jewish Europe] may produce this result we shall arrange elections in favor of such presidents as have in their past some dark, undiscovered stain, some Panama or other, then they will be trustworthy agents for the accomplishment of our plans out of fear of revelations."

THEIR WEAKNESS: CARELESS FORGERS MIXED DATES

This describes the election of Emile Loubet in France, who was connected to the "Panama Scandals" (a failed attempt at the construction of the Panama Canal by the French), but that didn't happen until 1899.
